SUMMARY STATEMENT: On May 21, 2019, in AM No. 19-042, the Assembly awarded contract bid no. 19-077B to Dirtworks, Inc. for the Lake Louise Boat Launch and Parking Lot Improvements project, Project No. 15019.

This contract included one Kids Don't Float kiosk to be constructed near the boat ramp and another in the parking lot. These kiosks are complete and awaiting life jackets. It was the intent of the State Office of Boating Safety to supply the life jackets but unfortunately with state budget cuts, the life jackets could no longer be provided.

Supplying the life jackets is essential in providing added safety measures for those who use this popular recreational area. Katie

Sechrist, the Alaska Department of Fish & Game (ADF&G) Grant Manager recognized how essential the life jackets are to boating safety by approving the use of project funds. It is for this reason that the scope of the project needs to be amended to include life jackets that will be made available in the Kids Don't Float kiosks.

As part of this project, the Matanuska-Susitna Borough Community Development Department, Recreational Services Division will replace any damaged or missing vests at the beginning of each boating season through the year 2038 which is the ADF&G/US Fish & Wildlife Service determined life of the project.

RECOMMENDATION OF ADMINISTRATION: Approve the amended scope of work of Project No. 15019, Fund 440 to include the addition of life jackets for the Kids Don't Float kiosks at the Lake Louise boat Launch and Parking Lot Improvements project.
