SUMMARY STATEMENT: The Operations and Maintenance Division (O&M) previously sought funding for the refurbishment of boilers in two aging thaw trucks from the Road Service Area, fund 265. The following projects were approved in Fiscal Year 2023: project no. 30092 6600 6624 for thaw truck boiler & assembly component replacement - truck #30, and project no. 30092 6600 6625 for thaw truck boiler & assembly component replacement - truck #65. However, the current cost of replacing the boilers on these two thaw trucks is comparable to that of acquiring a new 4x4 thaw truck. O&M's analysis indicates that the existing 18-year-old boilers pose safety concerns and are prohibitively expensive to repair, making refurbishment unjustifiable. Therefore, we are requesting an amended scope of work to facilitate the purchase of one new 4x4 thaw truck instead of refurbishing trucks #30 and #65.
