Alaska Safe Riders (ASR) On-Air Safety Tips



For decades Alaska has led the way for injuries and accidents related to all-terrain vehicles (ATV,) snowmachine and other off-road vehicle use. The Mat-Su Regional Hospital reported 314 off-highway vehicle related accidents resulting in injuries that required emergency room visits for 2021-2022.

When you see young children ripping down the side of the road on a 4-wheeler, barefoot passengers hanging on for dear life, no helmets and no other personal protection, you begin to understand why. Often just being reminded about what might happen if you hit an object, confront a large animal, fall through the ice or... ( the scenarios are pretty vast if you look at accident statistics for Alaska) raising awareness can and does change behaviors and saves lives.

ASR proposes to provide weekly 30-45 second safety tips to help Alaskan's learn the rules and enjoy and stay safe while riding, hiking and exploring the backcountry of our beautiful state. These sound bites provide positive, helpful reminders to follow simple protocols to follow the rules, avoid unintentional injuries, or manage emergencies that may come up.

To secure necessary funding to research, write and professionally produce these safety spots, we are working with Hatcher Pass Radio and The People's Paper (Make a Scene Media,) to secure appropriate sponsors to cover the cost of airing these weekly spots.

We believe these safety spots will have a positive impact on our community and help to increase awareness and reduce the number of unintentional injuries and deaths.
