SUMMARY STATEMENT: The Mat-Su Borough (MSB) awarded a Professional Services Agreement (22-063P) to Moffatt & Nichol (M&N) in the amount of \$100,000 on June 8, 2022, with a final completion date of December 31, 2022.

The inspection findings, pile conditions assessment, and recommended repairs were presented in a report submitted by M&N to the MSB in September 2022.

Amendment No. 1 for \$156,470, approved by AM 22-105, added additional detailed designs for pile repairs.

Amendment No. 2 for \$336,506, approved by AM 22-141, added additional support for construction management services, bid support, and environmental permitting.

Amendment No. 3 for \$ 207,573, approved by AM No. 22-151, added gravel barge ramp location selection and design service and extended the contract completion date to December 31, 2024.

The additional design services provided a Ramp Design Study (RDS) presented in a report submitted by M&N to the MSB on June 29, 2023.

This design effort was not supported by the EDA due to the extensive in-water work required by the RDS, which fell outside the approved EDA Scope of Work for the project funding. The entire cost of the RDS was paid for by the MSB with Port operating funds.

Additional funding is requested in the amount of \$615,915 for MSBfunded Barge Ramp Design and construction bid documents outlined in the RDS report.

Additional change order authority is requested in the amount of \$100,000 for re-design coordination for M&N with Western Marine Construction (WMC).

In accordance with MSB 3.08.170 (B) (3), staff requests approval of this contract amendment for Contract No. 22-063P, with M&N to add additional design services for the design of the barge dock ramp in the amount of \$615,915 and for additional change order authority of \$100,000 for a total of \$715,915.

Funding for this request is available in three separate project accounts, Barge Ramp Design is available in Project 70012-8400-8402 and change order authority is available in 70012-8400-8402 for 80% and 70012-1800-1801 for 20%, Port Mackenzie Dock improvements/Repairs.

RECOMMENDATION OF ADMINISTRATION: Approve Contract Amendment No. 4 for Moffatt & Nichol, Contract No. 22-063P, to add \$615,915 for gravel barge dock ramp design, bidding support/CM services, and approval of \$100,000 in change order authority for the Pile Sleeve project.
