A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE SCOPE OF WORK AND BUDGET FOR THE 2015 SOCKEYE FIRE DISASTER RELIEF MONIES, PROJECT NO. 55018.

WHEREAS, on June 14, 2015, a large wildland urban interface Alaska wildfire exacerbated by record high temperatures caused widespread damage to the community of Willow and the surrounding area in the Borough; and

WHEREAS, a disaster declaration was issued by the Mayor and the Manager; and

WHEREAS, costs incurred during the disaster were determined to be eligible for state and federal funding assistance; and

WHEREAS, emergency protective measures totaled \$57,186.28 and costs from fire suppression totaled \$37,434.26; and

WHEREAS, both categories are eligible for 75% reimbursement under the Fire Management Assistance Grant by the Federal Emergency Management Agency and 25% through Alaska Division of Homeland Security and Emergency Management; and

WHEREAS, recovery costs in the amount of \$10,000 for porta potty rentals are not eligible under the FMAG Program, but have been approved for reimbursement under the state disaster agreement (100%); and

WHEREAS, \$70,965.41 of expenditures from the disaster for emergency protective measures and fire suppression have been determined eligible for federal assistance; and

WHEREAS, \$33,654.93 of expenditures from the disaster for emergency protective measures, fire suppression, and recovery have been determined eligible for state assistance.

NOW, THEREFORE, BE IT RESOLVED, that the Matanuska-Susitna Borough Assembly hereby approves the following scope of work and budget for the 2015 Sockeye Fire disaster relief monies, fund 445, project no. 55018.

Emergency protective measures, fire suppression, and recovery and related costs caused by the 2015 fire disaster.
