A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE SCOPE OF WORK AND BUDGETS FOR FOUR BRIDGE PROJECTS; AND APPROVING A TIME EXTENSION OF THE AREAWIDE BUDGET APPROPRIATION AND FUND BALANCE APPROPRIATION FOR THE 2024 SUSHANA DRIVE AT LITTLE SUSITNA RIVER FLOODING MITIGATION.

WHEREAS, the intent and rationale of this resolution are found in the accompanying Information Memorandum No. 25-176.

NOW, THEREFORE, BE IT RESOLVED, that the Assembly hereby approves the scopes of work for Michelle Drive Bridge at Willow Creek Erosion Mitigation, Lewis Loop Bridge at Fish Creek, and King Salmon Drive Bridge at Cottonwood Creek.

## SCOPES WORK

For Michelle Drive Bridge at Willow Creek: Installation of armor rock along the streambank.

For the Lewis Loop Bridge at Fish Creek: Make upgrades to the superstructure and abutments for the Lewis Loop Bridge at Fish Creek.

For the King Salmon Drive Bridge at Cottonwood Creek: Preliminary design for the replacement of King Salmon Drive Bridge at Cottonwood Creek. Includes all necessary labor, materials, equipment, engineering, management expertise, traffic control, project representation and construction management.

BE IT FURTHER RESOLVED, that the Assembly hereby approves the budgets for the Michelle Drive Bridge at Willow Creek Erosion Mitigation project, the Lewis Loop Bridge at Fish Creek project, and King Salmon Drive Bridge at Cottonwood Creek project; and the

amended budgets for the Bridge & Railroad Crossing Major Maintenance and Repair project, the Hidden Hills Road Railroad Crossing Signal project, the 2024 Sushana Drive at Little Susitna River Flooding Mitigation, and the Bradley Road Bridge Replacement over Trapper Creek project.
