SUMMARY STATEMENT: The State of Alaska (SOA) Adopt-A-Highway (AAH) program conducts litter collection along State-maintained roads within the Matanuska-Susitna Borough (MSB). Under current AAH guidelines, participating volunteers are responsible for disposing of the refuse they collect. The MSB Solid Waste Division (SWD) charges standard disposal fees for all waste delivered to Borough facilities unless it qualifies under the approved MSB Community Cleanup Program. Because the Community Cleanup Program does not include State-maintained roads, refuse from SOA AAH cleanups is

subject to regular disposal fees.

The SOA AAH program has requested that the SWD waive disposal fees for waste collected on State roads within the Borough and delivered by AAH volunteers. The annual cost to the SWD for accepting this refuse is typically less than \$5,000.

MSB Code 8.05.090(C) prohibits free waste disposal, except by Assembly resolution. Approval of this resolution would allow the SWD to waive disposal fees for the SOA AAH program through June 30, 2027. Program administration, including verification of eligible loads, will be coordinated between the Solid Waste Division and the State of Alaska Adopt-A-Highway program staff
