**SUMMARY STATEMENT:**

\$500,000 in capital funding was appropriated to projects in both fiscal years 2022 and 2023 for land purchase for a new fire station for Central Mat-Su Fire Service Area. By working with Borough staff, we were able to locate existing Borough property that could be used in place of purchasing a privately owned lot for market value saving the need to utilize any of the \$1,000,000 set aside for that purpose.

As the land has been secured, the proposed intent is to re-appropriate the \$1,000,000 toward other aspects of the project such as site development, design, construction, and furnishings and fixtures.


