

SUMMARY STATEMENT: On April 14, 2022, the Matanuska-Susitna Borough Purchasing Division issued a solicitation requesting bids from qualified contractors to perform annual road maintenance for Road Service Area (RSA) #31, Alpine. Contractor will furnish all labor, materials, supervision, equipment, transportation and supplies for the maintenance of this RSA. Services purchased will support the Public Works Department in assembly district 1.

In response to the advertisement, two bids were received. Award recommendation is being made to Ficklin Construction as the lowest responsive and responsible bidder.

Following bid opening, cost reduction measures were initiated resulting in the award amount being presented at this time.

The term length for this agreement is for three-years with two additional one year renewals (potentially five-year contract), subject to annual appropriation of funds by the Borough Assembly.

In accordance with MSB 3.08.170(B), Administration requests authority to modify the resulting contract completion date by 30 days for unforeseen circumstances.

The Public Works Department, Operations & Maintenance Division will be administering the contract.
