A JOINT RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY AND THE ANCHORAGE MUNICIPAL ASSEMBLY IN SUPPORT OF HB 350 TO END THE SCHOOL BOND DEBT REIMBURSEMENT MORATORIUM.

WHEREAS, the Alaska Constitution mandates that the Alaska Legislature establish and maintain public schools; and

WHEREAS, the Alaska Legislature has established a framework in Title 14 of the Alaska Statutes to provide for local administration of schools in incorporated municipalities;

WHEREAS, various provisions of AS 14.11 pertain to a program of the State of Alaska whereby the State provides reimbursement to local governments for school bond debt AS 14.11; and

WHEREAS, the program existed for several decades without interruption and further solidified a framework whereby the state and local governments shared the costs of local education; and

WHEREAS, effective January 1, 2015, the State of Alaska placed a moratorium on the program; and

WHEREAS, the program moratorium was later extended to July 1, 2025; and

WHEREAS, HB 350 is a bill to end the moratorium as of July 1, 2022; and

WHEREAS, Schools, including construction and major renovation of school buildings, comprises a major portion of local expenditures; and

WHEREAS, ending the moratorium and allowing local governments to once again engage in cost sharing with the State will return to the historical framework which was in place for decades, provide safe and efficient schools for children in Alaska, and restore a portion of the Alaska Legislature's constitutionally mandated duty to provide for public schools.

NOW, THEREFORE, BE IT RESOLVED, the Matanuska-Susitna Borough Assembly and the Anchorage Municipal Assembly support HB 350 to end the moratorium on the school bond debt reimbursement program.
