SUMMARY STATEMENT: Assembly approval of contract amendments (change orders) are required by MSB 3.08.170(C) (2) for contracts with an original award value greater than \$100,000 up to \$500,000; a contract amendment or change order, or cumulative contract amendments or change orders that will cause the total contract amount, as amended, to exceed 125 percent of the original contract award, or to increase the original contract by \$100,000, whichever is less.
