## MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 22-092

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$11,762,000 TO FUND 430, ROADS & BRIDGES CAPITAL PROJECTS, FOR THE ACQUISITION, CONSTRUCTION, AND INSTALLATION OF CAPITAL IMPROVEMENTS WITHIN THE BOROUGH; AND \$238,000 TO FUND 430, FOR RELATED ISSUANCE COSTS FROM THE PROCEEDS OF THE 2022 SERIES A TAXABLE GENERAL OBLIGATION TRANSPORTATION SYSTEM BONDS.

WHEREAS, the intent and rationale of this ordinance are in the accompanying Informational Memorandum No. 22-170; and

WHEREAS, any funds remaining in excess of actual issuance costs shall be transferred respectively to the approved projects; and

BE IT ENACTED:

Section 1. <u>Classification</u>. This Ordinance is a noncode ordinance.

Section 2. Construction and Issuance Cost Appropriation. There is hereby accepted and appropriated \$238,000 for issuance costs and \$11,762,000 to fund 430, to the following projects to provide funds to finance the construction, additions, improvements, betterments, repair, reconstruction, or acquisition of public roads and facilities related thereto in the Borough, together with all necessary equipment and transportation facilities, and the acquisition of lands or rights in lands in connection therewith.

## Section 3. Project Description
