SUMMARY STATEMENT: The Mat-Su Borough approved contract award 21-150B to Roger Hickel Contracting, Inc. in the amount of \$33,270,169.00 on June 1, 2021 with a final completion date of September 1, 2022 through AM 21-048.

In accordance with MSB 3.08.170 (c), and authorized with adoption of AM No. 21-048 on 6-1-21, a 3.5% change order authority in the amount of \$1,164,455.92 was included with the contract award.

was awarded to pay for School District desired additive alternate enhancements which are not funded by FEMA. To date, three change orders have been issued totaling \$904,135.00.

Additional change order authority in the amount of \$500,000.00 is requested to accommodate historically high price inflation resulting in increased costs for building construction products, delays associated with COVID-19 related supply chain constraints and other unforeseen conditions.

In accordance with MSB 3.08.170 (B), staff is requesting administrative authority to modify the contract completion dates for unforeseen circumstances, including supply chain delays indirectly caused by the world-wide pandemic, and adverse weather conditions. The recommended new substantial completion date is December 16, 2022 with final completion on January 31, 2023.
