RESOLUTION SERIAL NO. 19-095**

A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY AMENDING THE BUDGETS FOR PROJECT NOS. 45066 AND 45076, FUND 405, TO FURTHER SUPPORT UPGRADES FOR THE CENTRAL MAT-SU FIRE SERVICE AREA TRAINING COMPLEX.

WHEREAS, in the fiscal year 2012 capital projects budget, \$252,000 in Central Mat-Su Fire Service Area funds were appropriated for maintenance and upgrades for various stations; and

WHEREAS, that project is now complete and there is a remaining balance of \$53,403.47; and

WHEREAS, in the fiscal year 2018 capital projects budget, \$150,000 in Central Mat-Su Fire Service Area funds were appropriated for security fencing for various stations; and

WHEREAS, that project is now complete and there is a remaining balance of \$21,000; and

WHEREAS, in the fiscal year 2020 capital project budget, \$500,000 was appropriated for training complex upgrades; and

WHEREAS, the Central Mat-Su Fire Service Area Chief anticipates needing more funding for the training complex upgrades and requests the residual funds with a combined total amount of \$74,403.47 from the above projects be reappropriated to project no. 45076-6604 to further support the training complex upgrades; and


WHEREAS, the Central Mat-Su Fire Service Area Board of Supervisors supports this reappropriation.

NOW, THEREFORE, BE IT RESOLVED, that the Matanuska-Susitna Borough Assembly hereby approves the amended budgets for Project Nos. 45066 and 45076 to further support the training complex upgrades.

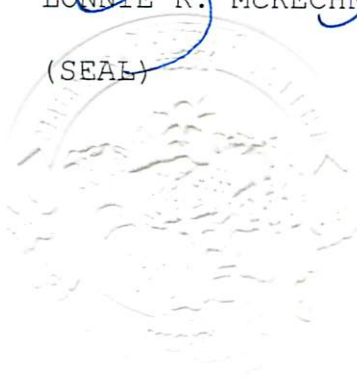
