SCOPE OF WORK

American Rescue Plan, Local Assistance and Tribal Consistency 2022 funding will be used for Assembly priority projects and grant match as follows:

35473 Non-Federal Grant Match - The Borough is the recipient of grants from various sources including State and Federal Agencies and Foundations. These grants traditionally, require the borough provide a cash match. This funding is being set aside to allow the borough to meet the match requirements of these grants.

15040 Parks and Recreation Projects - GPRA Overflow Parking lot. Funding will be used in conjunction with other funding for the design and construction of the Government Peak Overflow parking lot.

40205 Mat-Su Central School Construction

This funding will be utilized to fund construction of Mat-Su Central School.
