A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE SCOPES OF WORK AND BUDGETS FOR THE GPRA PARKING LOT PROJECT, THE PALMER FAMILY PARK PROJECT AND THE FIRST RESPONDER PREPAREDNESS PROJECT AND AUTHORIZING THE MANAGER TO SIGN THE MEMORANDUMS OF AGREEMENT.

WHEREAS, the intent and rationale of this resolution can be found in its accompanying Information Memorandum No. 23-129 and Ordinance Serial No. 23-060.

NOW, THEREFORE, BE IT RESOLVED, that the Matanuska-Susitna Borough Assembly does hereby approve the scopes of work and budgets for the GPRA Parking lot, the Palmer Family Park and the First Responder Preparedness projects.

SCOPES OF WORK

15040 Parks & Recreation Projects - GPRA Overflow Parking Lot

Funding will be used in conjunction with other funding for the design and construction of the Government Peak Overflow Parking Lot.

15040 Parks & Recreation Projects - Palmer Family Park

Funding will be provided as a grant to the non-profit organization Palmer Church of the Nazarene, and used to develop the fully inclusive, all accessible Palmer Family Park.

45158 First Responder Preparedness

Funding will be used to purchase, distribute, and maintain AEDs, including batteries, electrodes, and cases at key locations around the borough; and for the

implementation of First Pass and for one year of data maintenance for First Watch and First Pass web-based systems.
