Assemblymember Mayfield noted that sometimes public notices get ignored by the public and that sometimes things take longer than the public would like. Spoke to the possibility of changing the notification times to the public. Stated that he looks forward to the results produced by the advisory group.

Assemblymember Doty stated that she appreciates the comments provided by the public. Complimented the Assembly on agreeing to fund community councils so that they can form neighborhood watch groups. Spoke to the importance of neighbors organizing to protect their neighborhoods from crime and to have their voices heard.

Assemblymember Leonard spoke to concerns with substitute ordinances. Stated that when one comes forward that a new informational memorandum should accompany it. Thanked all the election workers who worked the State's primary election. Spoke to concerns with how dangerous Knik Goose Bay road is. Opined that it needs to be upgraded as soon as possible. Offered his condolences to the families whose lives have been impacted by losing loved ones to accidents on Knik Goose Bay. Spoke to the need for the State to fully fund Alaska State Troopers so that trooper levels in the Borough can be brought back up to where they should be.

Assemblymember Beck stated that he is thankful that he could be present during the meeting. Noted that he missed some meetings due to attending out-of-state family emergencies. Thanked staff for their dedication to serving the public.
