Mr. Spiropoulos advised that he and Ms. Bodolay will be at the National Attorney's Conference and will not be present at the next meeting.

Assemblymember Bernier thanked those that attended the meeting and said a prayer.

Assemblymember Hale thanked the public who testified to concerns with the language that was added to the election brochure. He noted that he agrees with them that it was a partisan statement and has no place in the Borough's election brochure. He further added that something of this magnitude should have had public input. Ms. McKechnie spoke to the number of election workers that are still needed. Noted that there is training and compensation provided.

Assemblymember Sumner thanked everyone that testified to their concerns about the election brochure. Noted that the Assembly does not always get everything right and that he has regrets as to how it has played out. Spoke to concerns with the length of the state and federal priorities legislation that will be up for public hearing at the next meeting. Advised that he will be making a motion to split it up into shorter more prioritized lists.

Alex Strawn, Planning and Land Use Director, provided a presentation on the Community Grown Solutions Study.

VII. MAYOR, ASSEMBLY, PLANNING COMMISSION, AND STAFF COMMENTS

Commissioner Zagorodniy spoke to his appreciation of the opportunity to participate. Stated that he is looking forward to working on community growth.

Commissioner Carpenter spoke to the need to focus on pedestrian paths and trails for safety. Noted the potential for growth down Knik Goose Bay Road. Spoke to the many impacts when it comes to locating schools.

Assemblymember Nowers spoke to townsite plans that were brought forward by former Mayor DeVilbiss. Spoke to the need to ensure safe travel for residents. Opined that the study is a good start. Noted the need to incentivize developers.

Commissioner McCabe spoke to the need to grow the economy and have a solid direction for growth.

Mr. Brown noted that the presentation was only an overview to provide information. Encouraged the Assembly to determine what projects they want to see worked on. Noted that the study will come forward as an informational memorandum. Commended the Borough's first responders for their dedication to the active shooter exercise this past weekend. Noted the many agencies that collaborated to make it happen. Advised that it was the largest exercise of its kind in the history of Alaska.

Commissioner Allen thanked Mr. Strawn for the presentation.

Ms. McKechnie advised that she had last reported that 19 hand count officials are still needed for the election., which is almost seven precincts. Requested that if the body knows anyone to please send them to the Clerk's Office.

Assemblymember Sumner spoke to the volume of the handout that was provided to the body. Stated that he has a lot of questions and concerns that he will be addressing. Spoke to the need to figure out a way to manage growth. Noted that he learned that Houston, Texas is the largest metropolitan community without zoning. Stated that he is unsure if the Borough needs zoning as Houston, Texas is doing well. Spoke to recent testimony about a fire that had occurred and noted that he had requested that report to fully understand what had occurred.

Assemblymember Gamble spoke to the need to protect recreation options and should be included in the report. Spoke to an event that the Mat-Su Health Foundation conducted with the communities of Houston and Big

Lake where projects were discussed that could be funded by the foundation. Noted projects that were chosen by the communities. Thanked the Foundation for hosting the event.

Assemblymember Fonov spoke to information presented in the fire report being conflicted with testimony presented. Noted that it was likely an emotional event for the owners.
