SUMMARY STATEMENT: Severe river flooding in Talkeetna between August 27 and September 5, 2023, obliterated roughly 350' of revetment and threatened critical infrastructure including public businesses, utilities, and historic properties.

To prepare for the potential emergency response and in accordance with MSB 3.08.320, the Borough procured 900 tons of RIP RAP from Western Construction and Equipment to be stockpiled in Talkeetna on September 9-10, 2023. That material remains pre-staged in Talkeetna and available for immediate use. The total cost to supply and deliver this initial order of materials was \$99,900.

On September 12, 2023, a disaster declaration was issued. In preparation for the larger project of repairing the damaged revetment, in accordance with MSB 3.08.290, the Borough issued two

separate Request for Quotes (RFQ) associated with the repair of the Talkeetna revetment. Both RFQs were publicly advertised and open to all qualified contractors.

On Tuesday, September 19, 2023, Purchasing received two quotes for supply and delivery of approximately 3,000 tons of RIP RAP. The lowest quote of \$320,000 (Western Construction) will supply and deliver materials to Talkeetna.

On Wednesday, September 20, 2023, Purchasing received 6 quotes to conduct revetment repair using owner-supplied RIP RAP. The lowest quote was \$93,750 (Western Construction). This work will be coordinated with the delivery of RIP RAP and is tentatively scheduled to commence no later than October 3, 2023.

This Information Memorandum is presented to satisfy the requirement of both MSB 3.08.320 and MSB 3.08.290 which require notification of the Assembly for waived procurements.
