A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE AMENDED SCOPE OF WORK FOR PROJECT NO. 47500, PURCHASE OF SELF CONTAINED BULLET HEATER 2/LIGHT TOWER AND DIAGNOSTIC TOOL FOR FLEET MAINTENANCE (50 PERCENT) AND A TIRE CHANGER AND A ROTARY LIFT, TO INCLUDE THE PURCHASE OF THE FOUR POST LIFT AND ACCESSORIES FOR THE FOUR POST LIFT, PROJECT NO. 47500

WHEREAS, The Operations and Maintenance has received an estimate of \$10,339 for the purchase of the four post lift and accessories for the four post lift; and

WHEREAS, the fiscal year 2016 capital project budget included \$45,000 in Operations and Maintenance funds for the purchase of a self-contained bullet cabinet heater 2/light tower, project no.47500; and

WHEREAS, Resolution No. 17-054 amended the scope of work to include the purchase of rolling air hydraulic jack system and accessories for rolling air hydraulic jack system; and

WHEREAS, Operation and Maintenance has received estimates and issued purchase orders in the amount of \$42,328.99, which will complete the purchase of the self-contained bullet cabinet heater 2/light tower and rolling air hydraulic jack system and leave a remaining balance in project no. 47500 of \$2,671.01; and

WHEREAS, the fiscal year 2016 capital project budget included \$3,250 in Operation and Maintenance funds for the purchase of a

diagnostic tool for fleet maintenance (50 percent), project no.47500; and

WHEREAS, Operation and Maintenance has received estimates and issued purchase orders in the amount of \$1,394.15, which will complete the purchase of the Diagnostic Tool for Fleet Maintenance (50 percent) and leave a remaining balance in project no. 47500 of \$1,855.85; and

WHEREAS, The fiscal year 2016 capital project budget included \$8,000 in Operation and Maintenance funds for the purchase of a tire changer, project no. 47500; and

WHEREAS, Operation and Maintenance has received estimates and issued purchase orders in the amount of \$6,902.86, which will complete the purchase of the tire changer and leave a remaining balance in project no. 47500 of \$1,097.14; and

WHEREAS, the fiscal year 2016 capital project budget included \$9,000 in Operation and Maintenance funds for the purchase of a rotary lift, project no.47500; and

WHEREAS, Operation and Maintenance has received estimates and issued purchase orders in the amount of \$3,736 which will complete the purchase of the rotary lift and leave a remaining balance in Project No. 47500 of \$5,264.00; and

WHEREAS, no expenditures can be made until the amended scope of work has been approved by the Assembly.

NOW, THEREFORE, BE IT RESOLVED, that the Assembly hereby approves the amended scope of work for the purchase of the self-contained bullet cabinet heater 2/light tower and diagnostic tool for fleet maintenance (50 percent) and a tire changer and a rotary lift, project no. 47500 to include the purchase of the four post lift and the accessories for the four post lift, project no. 47500.


