a new humidifier system, fire alarm upgrade and demolition of the old mentioned systems.

Change Order No. 1 added work for the outside fencing (\$21,813.10), Inpro-Continuum Wall Panels (\$53,350.80), Door Closer (\$1,163.17), Cleanout doors (\$3,124.49) and extend completion date to 6/20/25 through AM 24-085.

Change Order No. 2 added work to remodel the existing Animal Care reception counter to provide security and separation to customers. This change order added \$66,078.96 to the contract.

Change Order No. 3 included the installation of metal flashing to the bottom of the existing outside kennel walls where dogs have chewed through rigid insulation. The original existing flashing has deteriorated. This change order added \$3,929.94 to the contract.

Change Order No. 4 extended the contract to 12/15/25 through AM 25-066.

Change Order No. 5 adds work to relocate the x-ray machine, install a wet table, and relocate the water tanks. This change order adds \$27,628.67 to the contract.
