**SUMMARY STATEMENT:** This ordinance is sponsored by Assemblymember Sykes.

Service Area No. 23, North Colony Road Service Area, contains two distinct areas of service with a gap in the middle area. RSA 23 has a need for interested individuals to serve on the board of supervisors. One such person, Charles DeFriest lives in the middle area between the two geographical sections served by the service area.

Charles DeFriest has an interest in the operation of the service area because he is familiar with the roads in the area, the surrounding growth, and attending needs of the road system in the area. Charles DeFriest is a long time resident of the area and served as an on-call responder in the past. Mayor Halter has agreed to make the appointment of Charles DeFriest to RSA 23 Board of Supervisors, but MSB 5.15.010 provides that a member of

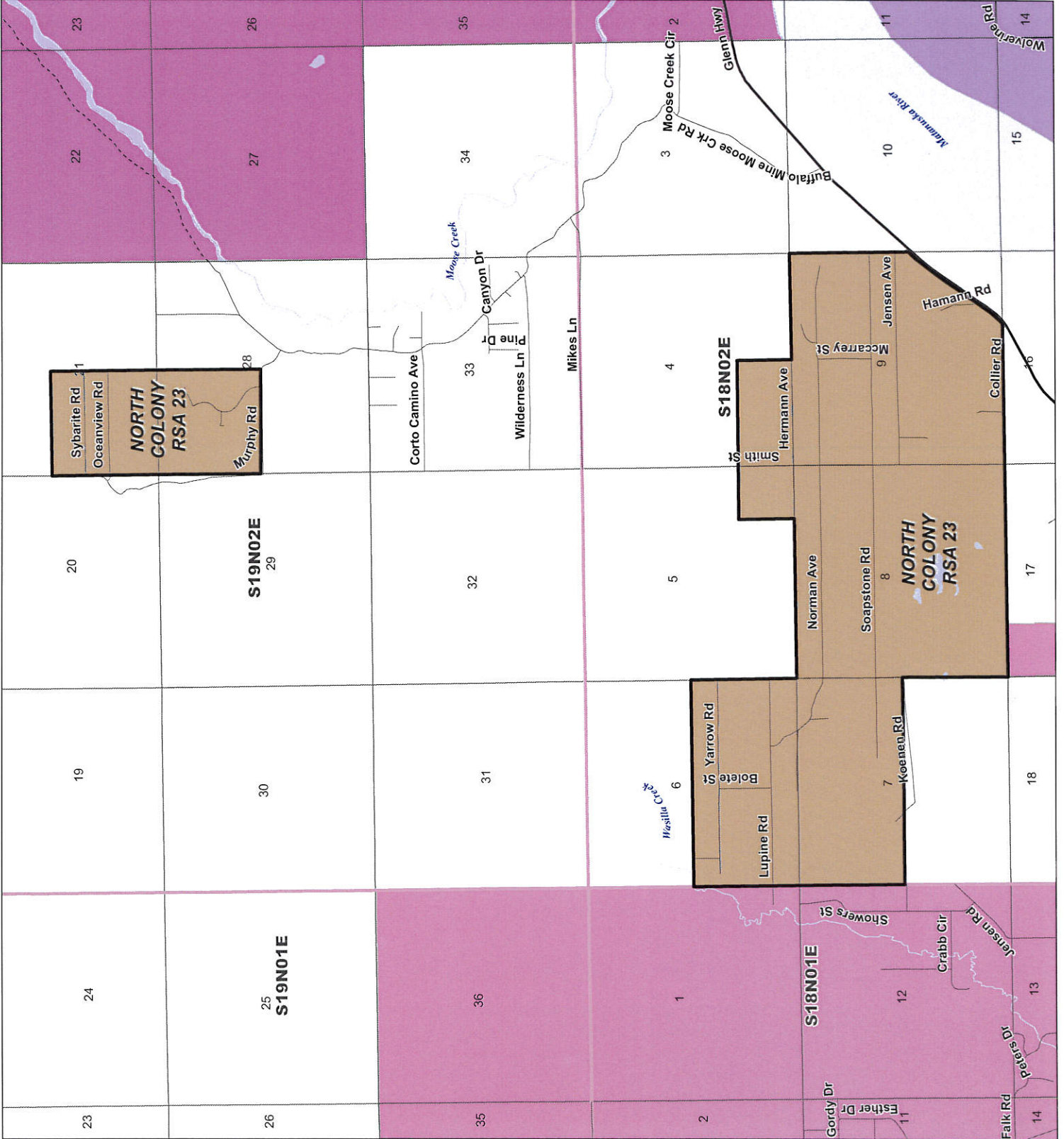
the Board must be a resident of the service area.

The attached ordinance will waive the provisions of MSB 5.15.010 and allow for the appointment of Charles DeFriest to RSA 23 Board of Supervisors. This ordinance will also apply to any future re-appointment should the Mayor seek to re-appoint Charles DeFriest for additional terms.

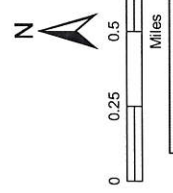
Finally, as noted in the ordinance, Charles DeFriest can only remain a member of Service Area 23, North Colony Road Service Area Board of Supervisors so long as Charles DeFriest remains a resident within Assembly District 1.
