#### SUMMARY STATEMENT:

The Public Works Department has been notified by the United States Fish and Wildlife Service (USFWS), National Fish Habitat Partnership (NFHP) that the Borough's grant application has been approved for a total amount of \$60,000 to improve the Cottonwood Creek fish passage at Fern Street.

This fish passage project will reopen at least 13.2 kilometers of upstream habitat above the crossing of Cottonwood Creek and Fern Street. The prioritization of this culvert is congruent with the Mat-Su Salmon Partnership Fish Passage Improvement Plan. This project is a part of a larger effort to improve fish passage throughout the Cottonwood Creek system.

The grant requires the Borough to match funds in the amount of \$60,000. Full match funding is available from the FY23 Areawide Budget Appropriation for fish passage improvement matching funds.

This match funding is scheduled to expire 6/30/2026. The Public Works Department requests the expiration date of the funding be extended to 12/31/2026 to coincide with the expiration date of the grant funding.

#### SCOPE OF WORK

#### 1. Project Description

The Service hereby incorporates the recipient's application submitted to and approved by the Service into these award terms and conditions.

Fish passage has been a focus of restoration activities in the Mat-Su Borough for over 15 years. Alaska Department of Fish and Game (ADFG) has assessed more than 580 crossings on fish-bearing streams with about 70% of them presenting some type of barrier to fish movement. To date over 100 culverts have been replaced with roads or bridges through the program, most on Borough-owned roads. This request will assist with funding one of these barrier removals within the Mat-Su Borough and primarily be used to re-open upstream habitat above the crossing of Cottonwood Creek and Fern Street. The project will result in at least 13.2 kilometers of upstream habitat being re-opened to juvenile salmonid movement. The prioritization of this culvert is congruent with the Mat-Su Salmon Partnership Fish Passage Improvement Plan. The proposal addresses Objective 4.2 of the current 2019 MSSHP Strategic Plan to restore culverts for improved fish passage.

The USFWS will coordinate with the Matanuska-Susitna Borough (Borough) to be onsite for specific construction milestones to ensure that the constructed projects conforms to FWS design standards, as planned. Milestones include site dewatering, culvert bedding, stream channel reconstruction, and re-watering of the channel. Additionally, we remain on call for technical assistance throughout the project lifespan. We are available for consultation on trouble shooting and field fitting structural and bioengineered/vegetative aspects of the plan.

Fish passage has been a focus of restoration activities in the Mat-Su Borough for over 15 years. Alaska Department of Fish and Game (ADFG) has assessed more than 580 crossings on fish-bearing streams with about 70% of them presenting some type of barrier to fish movement. To date over 100 culverts have been replaced with roads or bridges through the	
program, most on Borough-owned roads. This request will assist with funding one of these barrier removals within the Mat-Su Borough and primarily be used to re-open upstream habitat above the crossing of Cottonwood Creek and Fern Street. The project will result in at least 13.2 kilometers of upstream habitat being re-opened to juvenile salmonid movement. The

The Matanuska-Susitna Borough (MSB) is one of the most populous and rapidly growing areas of Alaska. Between 2000 and 2005, the MSB grew by 25 percent and exceeded 80,000 residents by 2007. According to 2023 Alaska Department of Labor estimates there are now almost 114,000 residents. According to a 2014 report from the University of Alaska's Institute of Social and Economic Research, if the MSB continues to experience population growth atits historic rate of 2%, the region's population is expected to reach 180,000 by 2040. One consequence of such growth is the rapid development of local road networks for access and transportation to residences, commercial centers, and recreational areas. The salmon and trout produced in MSB streams support commercial, sport, and recreational fishing industries and contribute in excess of several hundred million dollars to the Southcentral Alaska economy.

Juvenile anadromous fish, such as Chinook, coho, and sockeye salmon, spend up to three years in fresh water during which they must move up and downstream or between watersheds to access favorable habitat. Unrestricted access via stream corridors to spawning, rearing, and overwintering habitats is essential to maintaining salmonid production as well as healthy populations of resident trout and other fish (Jackson 2003). Movement of juvenile salmon and resident trout has been observed in response to a variety of environmental factors, including high and low flow events, changes in stream temperature, predation pressure, population densities and the availability of food or shelter (Gowan et al. 1994, Robison et al. 1999, Kahler and Quinn 1998). Studies in coastal Washington streams documented the movement of juvenile coho salmon, steelhead trout, and coastal cutthroat trout and determined that movers grew faster than non-movers (Taylor and Love 2003).

Improperly installed culverts and other fish passage barriers reduce or eliminate access to these preferred habitats, particularly for juvenile, small and weak swimming fish. One study estimated the loss in habitat from culverts on forest roads as 13% of the total decrease in coho salmon summer rearing habitat in the Skagit river basin in Washington State (Beechie et al., 1994).

Fern Street is the lowest remaining barrier on Cottonwood Creek, blocking a large proportion of the upstream Cottonwood Creek watershed, 71% of the watershed overall. Its removal will improve passage of fish 13.2 km up to Wasilla Lake (266.77 hectares) and various other lakes upstream. Providing significant habitat for adult and juvenile salmon upstream of the culverts as well as ensuring salmon can smolt out during periods of low flow.

This site at Cottonwood Creek and Fern Street represents three open-bottom arch culverts that are a barrier to both adult and juvenile salmon. The Borough's design standards for fish passage culverts are based on stream simulation and are consistent with the USFWS Culvert Design Guidelines for Ecological Function. A construction contract and a design contract will be issued for services form local private business, which will benefit the local economy. Construction equipment will take out the existing culverts and replace them with a larger, embedded culvert that will simulate the creek. Root wads or brush layering will be placed along any disturbed stream channel as necessary and disturbed areas will be revegetated with natural seed or vegetative mat from local areas. In addition to improving fish passage, installing correctly sized stream simulation culverts will greatly reduce the likelihood of catastrophic road failures in the future (Cafferata et al. 2004) and enhance aquatic habitat quality in the area adjacent to the road crossings for all aquatic organisms, especially for juvenile salmonids.

Partners involved in the project include the MSB, UFWS, and ADF&G. MSB will provide project management, contract the design engineering, construction and inspection activities and review and approve engineering plans. USFWS and ADF&G will also review the stream simulation design and advise the MSB. Additional outreach will be conducted by the Mat-Su Borough at the annual Transportation Fair, held every winter.
