


ADDENDUM NO. 24
to the
LEASE AGREEMENT
between
MATANUSKA-SUSITNA BOROUGH
and
GLACIER VIEW TRANSPORTATION

THIS ADDENDUM NO. 24 hereby amends the lease agreement between GLACIER VIEW TRANSPORTATION, INC. ("Lessor") and the MATANUSKA-SUSITNA BOROUGH ("Lessee") dated July 1, 1998, as follows:

PREMISES AND TERM.

Lessor does hereby lease, demise and let unto Lessee, and Lessee does hereby hire and take from Lessor those premises (hereinafter called the "demised premises"), consisting of approximately 576 square feet of net garage space, situated Lot I-3, Lee Subdivision, to be used for a garage for ambulance parking for the term commencing on July 1, 2022 and ending on June 30, 2023 at a rent of THREE THOUSAND SIX HUNDRED DOLLARS (\$3,600) per year, payable in full no later than July 15th, 2022.

Except as herein amended, all other terms, conditions and specifications remain the same.
