SUMMARY STATEMENT: The Public Works Department prepared a list of necessary road improvements throughout the Road Service Area 21 Big Lake.

Since the January 16, 2024, Assembly Meeting, when all RSA Road Improvement Project (RIP) Lists were approved except for RSA 21 Big Lake, which was pulled before approval. The RSA 21 Big Lake Board of Supervisors held two meetings on January 22 and January 29 to discuss the RIP List. The RSA 21 Board of Supervisors submitted their proposed RIP list via Resolution 24-01. The Public Works and the RSA RIP lists are different but share some projects.

The RIP List consists of the RSA's prioritized projects for the next five years. Public Works' staff included projects that the RSA has invested in complete construction bid-ready design packages or had some level of engineering initiated from prior lists supported by previous RSA 21 Big Lake Board of Supervisors and Assembly Members of District 5. Several projects identified are a continuation of previously approved projects. However, some project scopes have been modified.

Project funding sources will be road service area capital budgets. Target design and construction years are listed in the attached lists, which indicate the anticipated start year based on the existing capital budget and anticipated annual appropriation. These target dates are subject to change due to funding, rightof-way, utility relocations, shifting priorities, or Assembly approval.

Upon approval of these projects by the Assembly, Public Works Staff will continue working through prioritized projects.
