**SUMMARY STATEMENT:** On January 14, 2026, the Matanuska-Susitna Borough Purchasing Division issued a solicitation requesting bids from qualified contractors to remove and replace the Brett Memorial Ice Rink Flooring with ice rink rated flooring. The current flooring at the ice rink is approximately 26 years old and has exceeded its life span of 20 years and has become difficult to maintain. The Arena gets between 120-130K people per year with 75K skaters per year.

The Services purchased will support the Public Works Department in assembly district #2.

In response to the advertisement, two bids were received. Award recommendation is being made to Alaskan Industries Inc. as the lowest responsive and responsible bidder based on Total Bid Amount.

The final completion date for this project is May 31, 2026.

In accordance with MSB 3.08.170(B), Administration requests authority to modify the resulting contract completion date by 90 days for unforeseen circumstances.

The Public Works Department will be administering the contract.

**BRETT ICE RINK RUBBER FLOORING REPLACEMENT**

**1.01 General**

The Matanuska-Susitna Borough is requesting bids to remove existing Mondo ice rink rated rubber flooring and install new ice rink rated rubber flooring of equal or greater quality at the Brett Memorial Ice Areana, Located at 701 East Bogard Road, Wasilla, Alaska 99654. The flooring at the Brett Memorial Ice Areana is approximately 26 years old and has exceeded its life span of 20 years and has become difficult to maintain and needs to be replaced. The Areana gets between 120-130K people per year with 75k skaters per year.

**The installation must be performed and fully completed during the annually scheduled facility shutdown, from May 1 through May 31, 2026.**

- A. Contractor shall provide all labor, materials, tools, expertise, supervision, and miscellaneous supplies required to perform the work, within the stated period of time.
- B. Remove existing ice rink rubber flooring and palletize the salvageable material. Notify the MSB Project Manager when the salvageable material is ready for pickup. Prepare the substrate by filling cracks and divots with patch material in accordance with the flooring manufacturer's requirements.
- C. Work and access to the facility during the shutdown period will be unrestricted; however, the contractor shall submit an installation schedule identifying proposed working hours. This schedule will allow the facility manager to coordinate other maintenance activities during the shutdown.
- D. Preferred Manufacturers: Mondo (Ramflex® tiles) or equivalent. This is a specialty product that needs to be installed by an approved vendor.
- E. Approximate area: 7,600 Square Feet (estimate only); Contractor to field verify quantities and conditions during pre-bid.
- F. Color selections are identified in attachment #1. Final color selection will depend on product availability to meet the shutdown schedule for this project.
- G. Pre-bid will be conducted at an on-site visit. Attendance is strongly recommended to familiarize bidders with site conditions.

**1.02 Delivery, Storage, and Handling**

- A. Contractor-Owned tools and supplies may be stored on site at the contractor's risk. Storage locations will be coordinated with the Project Manager and facility manager.
- B. Materials delivered to the site shall remain in original, unopened shipping packaging until installation.

**1.03 Project Site Conditions**

- A. The contractor shall coordinate facility access requirements with the Borough for the duration of the contract period.

**1.04 Clean-Up**

- A. All debris related to the work shall be removed from the building at the contractor's expense. MSBSD and MSB dumpsters are not available for contractor use.
- B. The Contractor shall be responsible for temporarily moving and replacing any obstacles or furnishings necessary to perform the work.

**1.05 Project Schedule**

Construction is from May 1 through May 31, 2026.

**1.06 Warranty**

- A. One (1) year warranty on labor and manufacturer's standard warranty on Materials.

**1.08 Contract Closing**

- A. A Site inspection will be conducted with the Borough Project Manager and the contractor upon completion of the work. A punch list will be issued, and all items must be corrected prior to final acceptance.
