

**MATANUSKA-SUSITNA BOROUGH
RESOLUTION SERIAL NO. 24-130**

A RESOLUTION OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE SCOPES OF WORK AND THE BUDGETS FOR THE TUXEDO AVENUE BRIDGE REPLACEMENT PROJECT, AND THE MONTANA CREEK BRIDGE MAINTENANCE AND ARMORING PROJECT; APPROVING THE AMENDED SCOPES OF WORK AND BUDGETS FOR THE KEPLER DRIVE BRIDGE REPLACEMENT PROJECT, AND THE SHIRLEY TOWNE BRIDGE MAINTENANCE PROJECT; AND APPROVING THE AMENDED BUDGETS FOR THE MIDNIGHT DRIVE BRIDGE AND SNOWBALL CIRCLE BRIDGE PROJECT, AND THE BRIDGE AND RAILROAD CROSSING MAJOR MAINTENANCE AND REPAIR PROJECT.

WHEREAS, the intent and rationale of this resolution are found in the accompanying Information Memorandum No. 24-230.

NOW, THEREFORE, BE IT RESOLVED, that the Assembly hereby approves the scope of work for the Tuxedo Avenue Bridge Replacement project.

SCOPE OF WORK

Replacement of a one-lane bridge with construction of a new fish passage culvert and roadway widening to two lanes.

BE IT FURTHER RESOLVED, that the Assembly hereby approves the scope of work for the Montana Creek Bridge Maintenance and Armoring project.

SCOPE OF WORK

General maintenance including removal of the existing lead paint, repainting those portions of the Montana Creek Bridge, and installing additional armoring of the streambank upstream of the bridge.

BE IT FURTHER RESOLVED, that the Assembly hereby approves the amended scope of work for the Kepler Drive Bridge Replacement project.

AMENDED SCOPE OF WORK

Construction of the replacement of Kepler Drive Bridge Replacement project includes all necessary labor, materials, engineering, equipment, management expertise, traffic control, construction management and project representation.

BE IT FURTHER RESOLVED, that the Assembly hereby approves the amended scope of work for the Shirley Towne Bridge Maintenance project.

AMENDED SCOPE OF WORK

Conduct routine maintenance and repairs including guard rail and deck replacement for the Shirley Towne Bridge.

BE IT FURTHER RESOLVED, that the Assembly hereby approves the budgets for the Tuxedo Avenue Bridge Replacement project, and the Montana Creek Bridge Maintenance and Armoring project; and the amended budgets for the Kepler Drive Bridge Replacement project, the Shirley Towne Bridge Maintenance project, the Midnight Drive Bridge & Snowball Circle Bridge project, and the Bridge and Railroad Crossing Major Maintenance and Repair project.


