SUMMARY STATEMENT: On July 1, 2025, the Matanuska-Susitna Borough Purchasing Division issued a solicitation requesting bids from qualified contractors to provide labor, equipment and materials to furnish and deliver heating oil and fuels to 46 Borough facilities. Fuels include unleaded and diesel vehicle fuel as well as diesel fuel for emergency backup generators.

The contract price for heating oil and fuel is based on the Oil Price Information Service (OPIS) daily report for Anchorage, Alaska, on the date of delivery. Bidders were asked to submit a fixed dollar amount to be added to or subtracted from the OPIS price ("plus" or "minus" pricing). This method allows fuel pricing to remain responsive to market conditions and avoids the challenges of requiring a fixed per-gallon price in a volatile market. The attached bid analysis sheet shows the selected vendor's markup over OPIS rates and the estimated annual fuel markup cost to supply 46 Borough facilities.
