IV. PLEDGE OF ALLEGIANCE

Assemblymember Nowers noted that she appreciates the work of the board. Stated that she understands that it was a difficult process to find compromises that are equitable for all residents. Spoke to her appreciation of the meeting and the information received. Thanked the members for their service.

Assemblymember Hale thanked the Board for their hard work. Commented on what a long process it was. Noted that he does not want the recommendations to sit on a shelf and never be put into action. Advised that he has requested that an ordinance with their recommendations be brought forward to the Assembly to be referred to the Planning Commission and the Fish and Wildlife Commission.

Assemblymember Gamble thanked the Board for their recommendations. Spoke to his understanding of all the time and hard work that goes into serving on any advisory board. Noted his appreciation of their time and efforts.

Assemblymember Fonov noted it was hard for the Assembly to come up with solution for waterbody setbacks. Opined watercraft impact water quality and that perhaps there needs to be more data on what other things impact water quality. Noted that he does not want the Assembly to impose ineffective regulations. Opined that there is a possibility that it is not the houses or structures causing the poor water quality.

Assemblymember Sumner noted that most tanks for fuel heating are not 55-gallon drums and that a majority of them are over 300 gallons. Spoke to his knowledge about secondary containment systems for heating oil drums. Noted that he appreciates the work of the Board.
