SUMMARY STATEMENT: In 2020, COVID-19 created an immediate threat to the health and safety of the general public requiring emergency response and protective measures. A state and federal disaster declaration was issued on April 9, 2020 with the incident period beginning January 20, 2020. As part of the Public Assistance Program, allowed costs are eligible for 75% federal (Federal Emergency Management Agency-FEMA) and 25% state (Alaska Division of Homeland Security and Emergency Management-DHS&EM) funding assistance.

Eligible costs have been calculated and two awards have been issued

to reimburse the borough for expenses incurred through September 30, 2020, as follows:

Legislation will be brought forward to the assembly as the pandemic continues and additional costs incurred.
