XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Nicholas Spiropoulos spoke to appellate court rules having a 30-day appeal period deadline. Advised that the Supreme Court has the authority to shorten that timeframe. Noted that an opinion should be coming soon and as soon as it does he will share the information with the Assembly.

Assemblymember McKee opined that it important to take into consideration the advice provided to the Assembly by advisory boards.

Assemblymember Tew spoke to his understanding of how tipping floors for landfills work. Opined that they would be an asset to the community.

Assemblymember Hale noted that the Borough has a Transportation Advisory Board and the Local Road Service Area Advisory Board that the Assembly can get advisory opinions from regarding road service contracts.

Assemblymember Bernier thanked the Assembly for their support of his reconsideration of AM 22-011. Wished the body safe travels home.

Assemblymember Nowers stated that she is glad that Ordinance Serial No. 22-020 will have a public hearing. Opined that the Assembly should tap the current resources for advice before creating a new task force. Noted that soon there will be a new Alaska State Department of Transportation and Public Facilities in the Borough. Related that she will be attending the Alaska Municipal League Conference in Juneau. Spoke to the business Mat Valley Rebuild, which is a store that takes donations of all manners of used construction/home building items.
