SUMMARY STATEMENT: The MSB Assembly establishes a Borough wide schedule of rates and fees on an annual basis. Historically, the schedule of rates and fees for the Land and Resource Management Division (LRMD) have been contained within the LRMD Policy and Procedure Manual (PPM) and within the Assembly adopted schedule. The exclusive permit rates and fees was omitted from the annual schedule of rates and fees for 2026 adopted by the Assembly December 17, 2024 for fiscal year 2026.

The Land and Resource Management Division is proposing an update to the PPM that includes removing the rates and fees from the PPM.

The PPM update is scheduled to be introduced on November 18, 2025, with the Public Hearing scheduled for December 2, 2025. Removing the schedule of rates and fees from the PPM would result in a gap in schedule for rates and fees for an exclusive use permit.

In addition to a \$500 application fee, and a base rate of \$1000 for 7-12 months, or \$500 for 6-months or less, the rates and fees for an exclusive use permit are defined by LRM PPM Part 30 as follows: "Per acre charge for exclusive use of borough land: If a commercial permittee requests exclusive use of borough land, an additional fee shall be charged per acre or square foot of exclusive (whatever is appropriate), said fee shall be no less than twelve percent (12%) of the assessed parcel value per acre, or ten percent (10%) of fair market value as determined by third party appraisal.

Additionally, the attached resolution provides authority for the Borough Manager to set an appropriate fee for exclusive use land use permit issued on Borough land.
