## MATANUSKA-SUSITNA BOROUGH ORDINANCE SERIAL NO. 23-103

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY TO RETAIN FOR PUBLIC PURPOSE THREE PARCELS WHICH WERE ACQUIRED BY THE BOROUGH THROUGH TAX FORECLOSURE.

WHEREAS, the intent and rationale for this Ordinance are found in the accompanying Information Memorandum No. 23-235.

BE IT ENACTED:

Section 1. <u>Classification</u>. This Ordinance is a noncode ordinance.

Section 2. Retention for public purpose. Pursuant to Alaska Statute 29.45.460(a) and (c) the Borough retains the below described properties for a public purpose:
