Budget Public Hearing

I. CALL TO ORDER

The special meeting of the Matanuska-Susitna Borough Assembly was held on Thursday, April 29, 2021, at the Curtis D. Menard Sports Complex, 1001 South Clapp Road, Wasilla, Alaska. The meeting was called to order at 6 p.m. by Mayor Vern Halter.
