**MATANUSKA-SUSITNA BOROUGH  
ORDINANCE SERIAL NO. 20-032**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY APPROVING THE APPROPRIATION OF \$68,850.00 FROM PROJECT NO. 25048-2400-2416, FUND 420, AND \$75,000 FROM PROJECT NO. 25048-2400-2417, FUND 420, TO PROJECT NO. 25048-2400-2414, FUND 420; FOR AN INCREASED COST FOR THE FIRE SUPPRESSION & VENTILATION SYSTEM REPAIR/UPGRADE AT THE HAZARDOUS WASTE FACILITY / ADMINISTRATIVE OFFICE BUILDING AT THE CENTRAL LANDFILL.

WHEREAS, in the fiscal year 2020 Capital Projects budget, \$70,000 was appropriated for project no. 25048-2400-2416 for the purchase of a skid steer; and

WHEREAS, the skid steer was purchased using fiscal year 2019 budget funds and there remains \$68,850 in funding available; and

WHEREAS, in the fiscal year 2020 capital projects budget, \$75,000 was appropriated for project no. 25048-2400-2417 for the purchase of universal waste collection replacement facilities; and

WHEREAS, that project is not moving forward in the near future and there remains \$75,000 in funding available; and

WHEREAS, in the fiscal year 2020 Capital Projects budget, \$500,000 was appropriated for project no. 25048-2400-2414 for the fire suppression and ventilation repair/upgrades in order to comply with state of Alaska regulatory guidelines; and

WHEREAS, further funding is required to fully fund the fire suppression and ventilation repair/upgrades project engineers estimate.

BE IT ENACTED:

Section 1. Classification. This Ordinance is a noncode ordinance.

Section 2. Acceptance and Appropriation Source. The Assembly does hereby reappropriate \$68,850 from project no. 25048-2400-2416 and \$75,000 from project no. 25048-2400-2417 to project no. 25048-2400-2414 for the increased cost to repair/upgrade the fire suppression and ventilation system at the Hazardous Waste Facility/Administrative Office Building at the Central Landfill.

Section 3. Effective Date. This ordinance shall take effect upon adoption.


