Any future plan to obtain police powers will require additional voter approval.

Should the Matanuska-Susitna Borough investigate and consider steps to develop a proposal to voters that adds police powers to its responsibilities?"

Mayor Halter stated that he is not in favor of the Borough acquiring police powers. Stated that the Borough needs to put pressure on the State Legislature to fund more Troopers for the Borough.
