The following persons spoke in opposition to the proposed amendment to cut funding for Valley Community Recycling Services (VCRS): Ms. Molly Boyer, VCRS Executive Director; Mr. Barry Munsell; Ms. Amerika Powers, and Mr. Robert Wallace.

There being no others present who wished to testify, the public hearing closed and discussion moved to the Assembly.

#### VIII. MAYOR, ASSEMBLY, AND STAFF COMMENT

Assemblymember McKee stated that it is inappropriate for Assembly members to direct departments, as that is not what they were elected to do. Opined it is a waste of time to work on the budget when they have no idea what will happen with the State's budget. Opined that the mill rate should be set at 10.33 and to let the Manager figure out how to make that happen.

Assemblymember Mayfield opined that the body should have moved forward with deliberations. Stated that he is looking forward to doing the work at the next meeting.

Assemblymember Sumner opined that it is the Assembly's job to have the ability to move departments that were created by the Assembly. Further opined that it is our job to determine appropriations to departments.

Assemblymember Leonard stated that he appreciates the extra time to look at the amendments. Stated that if there are any large amendments, that it would be nice to see them in time to be able to research their impacts and ask questions. Related that if there are ways to improve the budget process for next year, that he would like to hear them. Noted that it is ultimately up to the Assembly to set the budget. Stated that he would be in favor of setting the mill rate and then adopt the budget if that is possible and then to include a rebate on tax bills if it becomes prudent to do so.

Assemblymember Beck spoke to the need to move slowly and make wise decisions regarding the budget. Noted that it is easier to wind down than to wind up. Stated that his sense is that the Borough operates on a slim budget as it is. Stated that services that are provided to citizens are good, but they are minimal. Related that he will be looking at amendments very closely. Opined that now is not the time for panic or fear, but for creativity and envisioning a better future.

Assemblymember Sykes spoke in support of delaying deliberations. Opined that it is good for the public to be able to see proposed amendments before they are moved. Stated that at times reorganization of departments can be a good thing, but that it probably should not be done through the budget process but should happen independently.

Mr. Moosey spoke to the seriousnewss of beetle killed spruce in the Borough. Stated that the Borough is working with Governor Dunleavy's Office and Alaska State Division of Forestry to mitigate wild fires. Related that they have come up with plan to advertise to the public to encourage homeowners to clear beetle killed spruce and to bring them to specific sites at transfer stations or the Central Landfill. Stated that the intent is to have

them chipped up. Opined that it is the least we can do to allow citizens to protect their own homes from wild fire.

Mr. Spiropoulos advised that he will look in to the possibility of setting the mill rate prior to adoption of the budget and to determine if it can be done practically and legally.

Ms. McKechnie spoke to how the budget amendment packets will be prepared.

Mayor Halter noted that it is quite the dilemma to not know what is happening with Governor Dunleavy's budget. Spoke to the possibility of changing the fiscal year to a calendar year in order to eliminate the timeline crunch we are under. Spoke in support of amending budget ordinance by substitute of last year's budget. Spoke to concerns with too many reductions this year having too large of an impact. Stated that he will be asking for a motion to substitute the Fiscal Year 2020 budget with the Fiscal Year 2019 budget.
