There being no others who wished to testify, the public hearing closed and discussion moved to the Assembly.

Mayor DeVries queried whether Assemblymembers believe they could have a conflict of interest.

Assemblymember McKee stated no.

Assemblymember Hale stated he builds roads but owns no gravel pits.

Assemblymember Bernier stated no.

Assemblymember Fonov disclosed he is a small excavation contractor and that he is not in the gravel business. Stated that the gravel pit that his family owned has been sold.

Assemblymember Nowers requested more information on the conflict of interest from the attorney and stated she is not in the gravel business and she would not benefit from the legislation and has no intention of getting into the gravel business.

Mr. Aschenbrenner recited the borough code on ethics and spoke to how it applies to conflicts of interest and financial interests.

CONFLICT OF INTEREST: Assemblymember Yundt spoke to his contracting business but does not have any gravel interest. Requested the Mayor to rule if he has a conflict of interest.

RULING: Mayor DeVries ruled that Assemblymember Yundt does not have a conflict of interest.

- (N) In issuing a decision acknowledging approving a registration, the planning director shall set visual screening, noise mitigation, lighting restrictions and road/access restrictions as appropriate for surrounding development and in accordance with development standards referenced in MSB 17.28.060. A decision by the Planning Director approving or denying registration is appealable as per MSB 15.39."
