Mayor Halter spoke in support of a road bond package. Stated that he would like to see Oilwell Road to Moose Road included. Spoke to the possibility of using a TIGER (Transportation Investment Generating Economic Recovery) Grant for that road.

Mr. Spiropoulos stated that when the Federal Government issues grants, there is a notice that explains what the grants are targeting.

Mr. Moosey, explained that TIGER grants are being replaced with the BUILD (Better Utilizing Investments to Leverage Development) program. Noted that this new program requires a grant match, which is being increased.
