Stated that the Assembly is trying to guarantee a minimum funding level to the School District. Spoke to the Borough's tax relief programs. Opined that it was a good meeting.

Assemblymember Kowalke wished everyone a good evening.

Assemblymember Mayfield expressed his condolences to the family of Ms. Jay Nolfi, as she passed away last Tuesday. Noted that Ms. Nolfi was a former member of the Assembly and worked tirelessly on Borough projects throughout her life.

Assemblymember Beck stated that he is thankful for the testimony provided by the public and noted that he was moved by some of it. Expressed his thanks for Borough staff. Related that he is grateful to be a small part of what is done to serve the public. Stated that he is looking forward to a new timber sale.

Mayor Halter noted that he learned a lot today. Summarized his intent for Ordinance Serial Nos. 18-014 and 18-015. Stated that the debt that is paid by the Borough for new school buildings is part of the way schools are funded. Stated that he understands the frustration of the School District when trying to plan their budget without all the information they need. Spoke to the need to be cautious with the timber sale contract. Stated that he would like to see it go forward. Spoke to concerns with the current lease

holder. Summarized the history and difficulty with that lease holder. Spoke to concerns with how the timber sale will impact Oilwell Road.
