SUMMARY STATEMENT:

The Central Mat-Su Fire Service Area restructured how they were distributing apparatus at some of their stations to better utilize available apparatus and reduce fleet size. Due to that restructuring, a 2009 4-wheel drive Pierce Velocity Pumper fire engine became available for purchase by a neighboring department.

The West Lakes Fire Service Area offered to purchase the engine as they would benefit from its specialized capabilities. The size and capabilities of the engine will enhance their response capabilities and is a good fit for their department and

needs. Purchasing the used engine is saving them considerable funds over ordering a new apparatus.

This was voted on and approved by each of the Fire Service Boards with the recommendation from the respective Fire Chiefs.

Administration recommends approval of the attached legislation which will approve an appropriation of \$200,000 from the West Lakes Fire Service Area Fund Balance, Fund 249, to the Central Mat-Su Fire Service Area Fund Balance, Fund 250, for the purchase of a used fire engine.
