SUMMARY STATEMENT:

The Borough uses the Cartegraph Asset Management software to manage and maintain its road and fleet assets. Cartegraph serves as the Borough's central system for tracking asset inventory, condition, maintenance history, and related data. Over time, the Borough has developed an extensive and detailed database of road and fleet assets within Cartegraph, which supports efficient planning, maintenance, and decision-making for public infrastructure and equipment.

The Borough seeks to enter into a three-year agreement with annual costs of \$83,689.91 in year one, \$87,037.50 in year two, and \$90,519.00 in year three, for a total cost of \$261,246.41. The agreement includes a negotiated, locked 4% year-over-year increase for licensing and training.
