Assemblymember McKee opined it was an exciting meeting.

Assemblymember Bernier thanked the public for attending the meeting. Spoke to his support of Resolution Serial No. 24-105 and thanked the body for supporting the legislation. Said a prayer.

Assemblymember Hale moved to direct the Manager to have staff assist the South Knik River Community Council in the development of a special land use district for their area, as approved with Resolution Serial No. 24-052.

The motion passed by the following vote:

Yes: 5 - Assemblymember Hale, Assemblymember Nowers, Assemblymember McKee, Assemblymember Gamble, and Assemblymember Bernier

No: 1 - Assemblymember Fonov

Assemblymember Nowers spoke in support of fish passage improvements. Spoke to her dismay at how low the fish returns are this year compared to years past.

Mr. Brown stated that staff will move forward with assisting the South Knik River Community Council with the development of a special land use district. Noted that there is plenty of time for legislation regarding the special land use district to come forward at a later date. Advised that he did not provide a Port MacKenzie update as there is currently a ship in port. Stated that if any members of the Assembly would like to visit the Port to let him know.

Assemblymember Gamble reminisced that in 60's there were so many fish that you could almost walk across them. Spoke to his concerns with low returns. Stated that he appreciates serving on the MSB Fish and Wildlife Commission, as he did not know how bad fish returns were until he was appointed
