**MATANUSKA-SUSITNA BOROUGH  
ORDINANCE SERIAL NO. 20-111**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY ACCEPTING AND APPROPRIATING \$7,225 OF REVENUES FROM FISCAL YEAR 2021 GENERAL FIXED ASSET SALES INTO PROJECT NO. 10151, FUND 435; AMENDING THE SCOPE OF WORK FROM FISCAL YEAR 2019 PROJECT NO. 10176-1906, FUND 435, SIDEWALK REPAIR; REAPPROPRIATING \$146,065.80 FROM PROJECT NO. 45168, FUND 480, INTO PROJECT NO. 10151, FUND 435, FOR AN ANIMAL CARE FACILITY KENNEL RESTORATION AND REMODEL PROJECT TO ENSURE ANIMAL CARE BEST PRACTICES AND IMPROVE SAFETY FOR STAFF AND VOLUNTEERS.

WHEREAS, the Animal Care and Regulation Division has received funds from the sale of a fiscal year 2021 fixed general asset in the amount of \$7,225; and

WHEREAS, these funds need to be accepted and appropriated to project no. 10151, fund 435, to be used for a facility kennel restoration and remodel project; and

WHEREAS, a scope of work amendment is required to allow the remaining funds of \$14,944.74 from the fiscal year 2019 project no. 10176-1906 to be used for the remodel project; and

WHEREAS, the remaining \$146,065.80 of nonareawide budget appropriation funds need to be reappropriated from project no. 45168, fund 480, to the facility kennel restoration and remodel project no. 10151, fund 435; and

WHEREAS, adoption of this ordinance will ensure animal care best practices by not only fixing the black mold problem found within the kennel area, but also remodeling the kennels to provide an entrance and an exit door within each dog kennel in order to increase the safety of employees and volunteers.

BE IT ENACTED:

Section 1. Classification. This Ordinance is a noncode ordinance.

Section 2. Acceptance, Appropriation and Reappropriation.

The Assembly hereby approves and accepts the appropriation of \$7,225 of revenues from fiscal year 2021 sale of general fixed assets into project no. 10151; the reappropriation of \$146,065.80 from project no. 45168, fund 480, into project 10151, fund 435, for the facility kennel restoration and remodel project.

Section 3. Effective Date. This ordinance shall take effect upon adoption.
