SUMMARY STATEMENT: On January 2, 2018, the Matanuska-Susitna Borough Assembly approved Am 18-005 awarding contract 18-064P to F-E Contracting Inc. not to exceed \$10,539,974 for Station 6-2 CM/GC construction.

On May 1, 2018, the Matanuska-Susitna Borough Assembly approved AM 18-03D awarding change order one in the amount of \$618,557.17 to finish design and construction due to a rise in construction materials, primarily driven by steel.

Change order two modifies the underground water tank booster pump

system, adds hose reels, chairs, projection screen, safety bollards, cell signal booster system and fencing. A contract extension to Sep 30, 2019 is requested to complete the owner requested work.
