SUMMARY STATEMENT: On July 10, 2025, the Matanuska-Susitna Borough Purchasing Division issued a solicitation requesting bids from qualified contractors to supply labor, materials, and equipment to improve approximately 4,350 linear feet of East Lakeview Road. The work includes resurfacing, rehabilitating the roadway's structure, clearing, excavation, and installing speed tables, culverts, signs, and striping. The Construction Services purchased will support the Public Works Department in assembly district #6.

In response to the advertisement, eight bids were received. Award recommendation is being made to QAP as the lowest responsive and responsible bidder based on Total Bid Amount.

The final completion date for this project is December 15, 2026.

In accordance with MSB 3.08.170(B), Administration requests authority to modify the resulting contract completion date by 90 days for unforeseen circumstances.

The Public Works Department, Project Management Division, will be administering the contract.

SCOPE OF WORK

General

This project's purpose is to upgrade approximately 4,350 linear feet of E Lakeview Road. The project area is located off of E Seldon Road approximately 2.5 miles north of the E Palmer-Wasilla Highway in Wasilla, Alaska. See project location and vicinity maps.

All construction shall be completed in accordance with the Alaska Department of Transportation and Public Facilities (ADOT&PF) Standard Specifications for Highway Construction (SSHC) 2017 Edition. Project specific special provisions are provided in the following sections. The requirements contained in these specifications and special provisions are hereby made a part of this solicitation and resultant contract.

Contractor is to provide resources to complete this project without any adjustments in the original bid amount or contract time.

Supply labor, equipment, materials and supplies to perform the required work as shown on the plans.

The Contractor is required to submit a Borough Construction Permit application for any partial or full road closures. The application shall be coordinated with the Borough Project Manager, and the project number must be clearly referenced on all submitted materials.

The Contractor shall provide a proposed construction schedule. The Contractor shall periodically or, as requested, update the schedule.

The Contractor must designate a primary point of contact for public inquiries related to the construction project. The contact person's details must be submitted to the MSB Project Manager within seven (7) days of the contract award. This information will be included in all construction notices distributed to residents in the project area. The designated contact must be accessible during normal business hours, capable of addressing resident concerns, providing updates, and coordinating any project-related issues with the MSB Project Manager. The Contractor is responsible for keeping this contact information accurate and up to date for the duration of the project. Any changes must be communicated to the MSB Project Manager within two (2) business days. Additionally, the Contractor must ensure that the designated contact is trained and prepared to handle public inquiries effectively, including addressing complaints and providing timely responses.

No utility relocation work has been performed and is not anticipated during construction. Utilities found to be in conflict will be attempted to be avoided during construction, to maintain budget, by eliminating or adjusting earthwork as approved by the MSB Project Manager or Inspector.

Work Zone speed limit: Limit speed of vehicles associated with the construction to 25 mph within project limits.

Complete work between 7am and 7pm. Extensions will be considered and approved by MSB Project Manager or Inspector.

Time is of the essence. All work shall be substantially complete no later than August 31, 2026, and Final Completion shall be obtained by December 15, 2026.

Estimated project magnitude is less than \$850,000.
