XII. MAYOR, ASSEMBLY, AND STAFF COMMENTS

Assemblymember McKee stated that she would like to understand more about the differences in state, city, and borough elections.

Assemblymember Hale stated that the Assembly knew the legislation to disband the Wastewater and Septage Advisory Board (WASB) was coming as the body directed staff to stop spending time on that board. Stated that since it has not been, perhaps they could look at how to develop a utility and who best to run it besides government.

Mr. Brown stated that if the Assembly has ideas for what the WASB could work on to please request legislation come forward. Advised that the School District had requested the Assembly to attend the September 28, 2022, meeting regarding the Mat-Su Central School. Noted that after discussion with the Clerk, he advised them that there was insufficient time to advertise and therefore the Assembly cannot attend as a whole. Noted that he would be in attendance and would report back to the Assembly.

Ms. McKechnie advised that the state of Alaska runs the state and federal elections. Commented that the cities and Borough's run their own elections. Noted that the Alaska State Division of Elections is working with her on precinct logistics in order to make the experience less confusing for voters.

Assemblymember Yundt opined that the WASB could focus on making recommendations regarding leachate. Spoke in support of forward funding for Mat-Su Central School instead of going into debt by bonding for it.

Assemblymember Nowers agreed that the WASB could focus on what to do with leachate. Noted that it is less expensive for tax payers if the school is funded with the debt reimbursement money from the state instead of being bonded for. Advised that her vote on introducing Ordinance Serial No. 22-119, did not mean she is opposed to the legislation. Stated that she is concerned that the legislation and the process it is proposing will not get the attention that it deserves because of the short amount of time between introduction and public hearing. Spoke in support of doing the right thing the first time. Thanked the body for supporting the C-PACE legislation

Assemblymember Sumner thanked the body for respecting the rights of other members.

Assemblymember Bernier said a prayer.

Mayor DeVries thanked Ms. McKechnie for keeping her on track.
