SUMMARY STATEMENT: The septic system at Butte Elementary is failing, requiring weekly pumping, and needs to be replaced before the next school year. The estimated cost is \$175,000.

The letter of agreement (LOA) between the Borough and the School District for the Houston Middle School funding allocated \$1,500,000 to expenses related to the reset work for the old high school. The work under the LOA was completed with a balance of \$89,417.09.

This remaining funding, along with \$85,582.91 in remaining insurance proceeds will be used to fund the critically needed repairs to the Butte Elementary School septic system. Advancing this legislation provides the School District with the flexibility to address the issue as quickly as the weather allows to keep pumping costs down.


