**SUMMARY STATEMENT:** On April 16, 2025, the Matanuska-Susitna Borough Purchasing Division issued a solicitation requesting bids from qualified contractors to purchase one (1) rough terrain cargo crane to be delivered FOB to the Matanuska-Susitna Borough Point MacKenzie Port facility. Goods purchased will support the Administration Department in multiple assembly districts.

In response to the advertisement, one bid was received. Award recommendation is being made to Construction Machinery Industrial as the lowest responsive and responsible bidder based on \$1,163,390.00.

The final completion date for this project is December 31, 2025. subject to annual appropriation of funds by the Borough Assembly.

**Project Overview:** The Matanuska-Susitna Borough is seeking to procure one (1) Rough Terrain Cargo Crane to support operations at the Port MacKenzie facility. The purpose of these specifications is to establish the basic requirements and to allow Port Operations staff to specify minimum technical and performance criteria.

This federally funded purchase is subject to compliance with the Buy America Act. All bid submissions must include a manufacturer signed Certificate of Buy America Act Compliance. Additionally, the successful bidder will be required to submit an EEO-1 Certification and Certification of Offer/Bidder Regarding Tax Delinquency and Felony Convictions.

The Matanuska-Susitna Borough, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it will affirmatively ensure that for any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.
