SUMMARY STATEMENT: On May 19, 2022, the Matanuska-Susitna Borough Purchasing Division issued a solicitation requesting bids from qualified contractors to pave 3,800 linear feet of W. Silver Drive and 5,800 linear feet of N. Sasbo Bluff Loop. This project involves, but is not limited to roadway reconditioning, import and placement of base course, pre-leveling, and paving of the roadway, construct gravel shoulders, driveway tie-ins, cul-de-sacs, public approaches, and mailbox pullouts. Construction Services purchased will support the Public Works Department in assembly district #7.

In response to the advertisement, two bids were received. Award

recommendation is being made to Northern Asphalt Construction, Inc. as the lowest responsive and responsible bidder based on Total Bid Amount.

The substantial completion date for this project is August 31, 2022 with the final completion of June 30, 2023.

In accordance with MSB 3.08.170(B), Administration requests authority to modify the resulting contract completion date by 30 days for unforeseen circumstances.

The Public Works Department, Project Management Division will be administering the contract.

SCOPE OF WORK

General

This project's purpose is to pave 3,800 linear feet of W. Silver Drive and 5,800 linear feet of N. Sasbo Bluff Loop. This project involves, but is not limited to roadway reconditioning, import and placement of base course, pre-leveling, and paving of the roadway, construct gravel shoulders, driveway tie-ins, cul-de-sacs, public approaches, and mailbox pullouts.

All construction shall be completed in accordance with the Alaska Department of Transportation and Public Facilities (DOT&PF) Standard Specifications for Highway Construction (SSHC) 2017 Edition. Project specific special provisions are provided in the following sections. The requirements contained in these specifications and special provisions are hereby made a part of this solicitation and resultant contract.

- This project is located west of Wasilla off North Pittman Road. This project may be accessed by proceeding west along Parks Highway to the N. Pittman Road intersection, turn right then follow Pittman to its intersection with W. Silver Drive.
- Contractor is to provide resources to complete this project without any adjustments in the original bid amount or contract time.
- Request locates from the utilities having facilities in the area. Use the Alaska Digline, Inc. Locate Call Center. See Section 105-1.06 for digline number and a list of utility companies in the area.
- Work Zone speed limit: Limit speed of vehicles associated with construction to 20 miles per hour within project limits.
- Time is of the essence. Work shall be completed in one continuous timeframe after utility relocations are completed. Substantial completion shall be achieved by August 31st, 2022. Final completion shall be achieved by June 30th, 2023.
- Estimated project magnitude is less than \$725,000.
